Oxford University Innovation has created a new and exciting 6 month internship opportunity in our Licensing & Ventures Group specifically for Social Sciences and Humanities. Interns work alongside Licensing and Ventures Managers in the management of projects, assisting with other activities in the Licensing & Ventures Group and enabling the transfer of as much research as possible from the University of Oxford to external organisations in order to create a positive impact in the world.

In addition to gaining experience supporting specific commercialisation projects, interns will also receive training and mentoring to develop their commercial skills and build awareness and understanding of the key principles and requirements of this exciting industry.

Representative activities which you may be involved with:

- Building a network of relationships with researchers and contributing to a vibrant culture of entrepreneurship and enterprise across the University to enable a flow of new ideas.
- Assisting with invention disclosure assessment, including market evaluation and looking at any existing, competing Intellectual Property and ideas.

- Assisting with preparing applications to our seed and proof-of concept funds and to 3rd party translational funding schemes.
- Assisting with generating high quality marketing materials for promoting Oxford ideas.
- Assisting with identifying and actively seeking out potential licensees for projects.

The successful intern will work on a broad range of projects but will have the opportunity to work on projects that match their background where possible.

Successful applicants will demonstrate a passion for entrepreneurship and enterprise, and ideally possess some experience of related activities. Successful candidates will also need to demonstrate excellent interpersonal and relationship management skills and very strong communication skills, both verbally and in writing.
