The airport is about 25 mins away by train. There are two types of trains -

- 1) S-bahn - from the airport take S7 in the direction towards Vienna city centre. Get off at Praterstern and go the U-bahn station below from where you can take the U2 and the university is only one stop away at station Messe-Prater. The S-bahn costs about 4 Euro.
- 2) CAT- this one takes 15 mins from the airport to the city center (Wien-Mitte) but from there you need to change two trains to get to the university. And it costs around 15 Euro plus you will have to take the city ticket anyway. So not advisable.
