Breid O'Brien – Steering Committee Chair

Breid has recently left the NHS after a long career working in frontline health services, and at Regional and National level. Her most recent position was as Director of Innovation and Digital Health at NHS England, leading a team supporting the national implementation of technology to enable people to be cared for at home who would otherwise need to be in hospital.

As a Registered Nurse, Breid specialised in Emergency Care in both the UK and Australian healthcare systems before moving into operational management and leadership roles. She completed a Master's degree majoring in management at the University of Technology Sydney; on her return to the UK in 2000, she took a Master's in Healthcare Informatics at Kings College London. Since 2003 she has worked in technology and change management roles. She is especially interested in utilising research and evidence-based improvement science to support technology enabled change and was a co-author of the publication ["Optimising the impact of health services research on the organisation and delivery of health services: a mixed-methods study".](#)

Breid's major interest is transformation enabled by technology and she has been a strong advocate for the alignment of improvement science and technology, having studied with the Institute of Healthcare Improvement (Boston).

She is now working as an independent transformation consultant, with a continuing focus on supporting technology enabled improvement within the health and care system.

Bola Akinwale is Deputy Director, National Healthcare Inequalities Improvement Programme, NHS England. She currently leads NHS England's policy on health inequalities, with a particular focus on promoting action to promote inclusive digital healthcare, and to driving up use of data for action on health inequalities.

Bola is a health policy professional who has worked in a variety of national policy, strategy and evidence roles across the health and care system. Her recent roles have included developing the strategy for adult social care reform, leading strategy and analysis on the government's work and health strategy and acting as Scientific and Programme Lead for Health Equity at Public Health England.

She has an interest in the effective usage of data and technology and particularly in the ethical issues surrounding the delivery of care.

Jonny Brown is a Deputy Director in the Outpatient Transformation Programme at NHS England. Before and during the pandemic he led national work to scale up the use of video consultation technology to support delivery of outpatient care across acute and mental health NHS trusts in England. In his role he continues to work with NHS providers to further adopt technologies that support remote care uptake. Previously he worked at the healthcare regulator Monitor within the provider regulation team and as an economist. He also spent four years as a senior advisor to the CEOs of Monitor and NHS Improvement. Before working in healthcare, Jonny worked in finance at Deloitte, Arthur Andersen and Goldman Sachs. Jonny holds a masters in International Relations and Economics and is a qualified chartered accountant (ACA).

Her career spans the prevention of poor health and inequalities, including digital health equity. Alisha is an NHS Consultant in Public Health and interested in the opportunities to advance innovation in digital health, data science and AI for public health. She holds postgraduate degrees in epidemiology, demography and public health from the London School of Hygiene and Tropical Medicine, and an Honorary Professorship at Swansea University.

Using the Scottish Approach to Service Design ensures all national Remote Health pathways are designed collaboratively with key stakeholders to enable widespread adoption across NHS Scotland boards.

Daniel Lasserson

Dan Lasserson is Professor of Acute Ambulatory Care at the University of Warwick, working clinically in acute ambulatory care and the hospital at home service for Oxford University Hospitals NHS Foundation Trust and Sandwell and West Birmingham NHS Trust, and is the President of the UK Hospital at Home Society. He has previously worked in primary care as well as hospital medicine and is the Theme Lead for Acute Care Interfaces in the NIHR Applied Research Collaboration (ARC) West Midlands. He is also Theme lead for Acute Ambulatory Care in the NIHR Community Healthcare MedTech and In-Vitro Diagnostic Cooperative (MIC) and has an interest in how point-of-care diagnostics can support acute care decision making. He is the chief investigator of an NIHR Policy Research Programme

study examining the optimal acute medical care delivery model during winter and waves of COVID-19. He leads the NIHR STOPAPE trial on the management of sub-segmental pulmonary embolism, an NIHR PRP funded study on how Acute Hospital at Home models can expand their scope of clinical work and sits on the Clinical Reference Group for NHS England's Virtual Ward/Hospital at Home Programme. He has led the Society for Acute Medicine national hospital benchmarking audit (SAMBA) and now sits on the Society for Acute Medicine's Research Committee as well as the Editorial Board of the Acute Medicine Journal.

Geraint Lewis

Geraint Lewis is the Director of Population Health at Microsoft. With 11 years' experience working as a doctor in acute and emergency medicine, followed by 5 years' higher specialist training in public health, Geraint is a consultant public health physician with a specialist interest in predictive modelling and population health management. His previous roles include Senior Fellow of the Nuffield Trust; Senior Director for Outcomes and Analytics at Walgreens; and Chief Data Officer at NHS England.

A fellow of both the Royal College of Physicians of London and the UK Faculty of Public Health, he is the lead author of the postgraduate textbook 'Mastering Public Health' and has published over 40 peer-reviewed papers in high impact journals including Health Affairs, JAMA, and the BMJ. Geraint was a Commonwealth Fund Harkness Fellow in Healthcare Policy and Practice at New York University. His awards include the National Directors' Award at the US Department of Veterans' Affairs; the Bradshaw Lectureship of the Royal College of Physicians of London; overall winner of the Guardian Newspaper's Public Service Awards; and an unprecedented four Health Service Journal awards for the Virtual Wards project that he conceived and led.

Steve Peddie

Steve Peddie has worked in a wide variety of roles in local government over nearly 40 years, including Executive Director roles covering Adult Social Care, Children's Services, Public Health and Housing. He currently has a national leadership role around promoting digital technology in Adult Social Care, as a Care and Health Improvement Adviser at the Local Government Association and is a partner Senior Adviser to the NHS Transformation Directorate (NHSE and DHSC), largely working on digitising social care.

Steve is also currently director of Dorset Council's Reform Programme.

Steve remains a registered social worker and is committed to close cross-organisational collaboration and championing innovation that helps people who draw on care and support to have a life, not a service.

Rebecca Rosen is a Senior Clinical Fellow at the Nuffield Trust where her research interests focus on primary care; organisational models for general practice and digital technology in general practice. Rebecca originally trained in public health and health services research and subsequently qualified as a GP. She has been a GP in South East London for over 20

years and has a particular interest in continuity of care. She also has practical experience of clinical commissioning and was co-lead of an integrated care pioneer programme in Greenwich. She is the chair of a small charity promoting dialogue and understanding between artists and scientists.

David Russell is the deputy director for the national Virtual Wards programme in NHS England which is aiming to deliver 40-50 virtual ward ‘beds’ per 100k population. Previously David has worked in NHS strategy and policy including supporting the development of the NHS Long Term Plan and People Plan. Additional national NHS leadership roles include the rollout of urgent community response teams and healthy new towns. Previous roles have also included delivery of innovative support programmes across the charity and social care sectors. David is the chair of trustees for the intergenerational arts charity Magic Me, has a MSc in healthcare leadership and an MA in Modern Literary Studies.
